## <u>Terms and Conditions for Conducting Free Roaming Dog Survey for Junagadh Municipal</u> Corporation, Junagadh

- **1.** Bidder has to send proposal in context to EOI for Conducting Free Roaming Dog Survey for Junagadh Municipal Corporation, Junagadh.
- **2.** Bidder has to Submit dully filled, signed and stamped proposal form and attached relevant documents along with proposal.
- 3. Bidder has to submit proposal to <u>VETERINARY DOCTOR</u>, <u>CATTLE POUND DEPARTMENT</u>, <u>2<sup>nd</sup>Floor</u>, <u>JUNAGADH MUNICIPAL CORPORATION</u>, <u>JUNAGADH</u> (GUJRAT) on or before date mentioned in EOI.
- **4.** Bidder has to submit details of methodology of Dog census to be used for this survey.
- **5.** Successful bidder has to carryout Agreement with JuMC by their own cost on stamp paper as per government rules.
- **6.** Report must include following data.
  - **a.** Ward wise and total number of Free Roaming Dog in JuMC areas.
  - b. Ward wise and total number of Sterilized Male, Non- Sterilized Male, Sterilized Female, Non- Sterilized, Sterilized Male puppy, Non- Sterilized Male puppy (above 6 months), Sterilized Female puppy, Non- Sterilized Female (above 6 months), puppy below 6 months, pregnant Female, Lactating Female etc Free Roming Dog in JuMC areas.
  - **c.** Ward wise and total number of Free Roaming Dogs having Low body condition scores, which are until for sterilization (Skin Infection, weak & debilitated, major injuries etc.) in JuMC areas.
  - **d.** Ward wise and total percentage of above indicators of Free Roaming, dogs in JuMC areas
  - **e.** Ward wise and total Dog -human ration and Dog density details of Free Roaming Dogs in JuMC areas.
- **7.** For Free roaming dog survey for JuMC will provide following data/help as per readymade data available with JuMC.
  - **a.** JuMC Map having boundaries for each ward.
  - **b.** Human population as per last census.
  - **c.** Dog sterilization and Vaccination data.
  - **d.** Temporary ID Cards for survey staff to avoid any conflicts.
- **8.** JuMC will provide exiting office for work at Dog Centre (Along with JuMC staff & ABC working staff) on temporary basis as per availability.
- **9.** JuMC will provide Accommodation at Dog Centre (Along with & ABC working staff) on temporary basis as per availability.
- **10.** If Bidder needs more office space or facility or accommodation, they have to arrange by bidder. No extra any payment shall be paid.
- **11.** All staff expenditure, vehicle expenditure, IEC material expenditure, food expenditure, any hardware, printing cost, report cost etc shall be borne by bidder.
- **12.** Entire survey work shall be done in an open and transparent manner without hiding any facts and findings.

- 13. Bidder has to submit free roaming god survey report within 90 days of work order issued.
- **14.** Penalty: if report shall be submitted late, after 90 days, Rs.1000/- per day penalty shall be imposed and shall be deducted from bill.
